That is NOT acceptable. I will not support any additional funding for public schools until overall test scores improve! There is too much bloat in school administrations; if we reduce admin staff we can increase teacher pay. We need to hold school boards responsible and demand, and then expect, better educational outcomes. I do not believe the teachers unions act on the behalf of our children.

Multiple bond initiatives have also given the Board another avenue to tax our residents. It is time for Wake County government to live within its means and lower the tax burden on our residents. As the Wake Commissioner for District 6 I will fight to lower taxes and get your county government to budget spending priorities, just like you do around your kitchen table.

Crime is on the rise nationally, and while Wake County is statistically considered one of the safer areas of the country, we have not been immune to the trend of increasing crimes against persons and property. In fact, one set of statistics indicated in the area encompassing District 6, you have a 1 in 19 chance of being a victim of crime, compared to 1 in 58 in the southwest part of the county. To coincide with the rise in crime, we have seen a reduction in law enforcement. The Board of Commissioners' most recent budget summary indicated the Sheriff's Department had over 200 vacancies. Public safety should be the top priority of the Board. If we don't prioritize public safety in Wake County the rise in crime will continue and Wake will begin to resemble other once prosperous areas around the country. Fighting to increase public safety will be a top priority for me.

For nearly a decade the Wake Co. Board of Commissioners and the Wake Co. School Board have been under single-party rule. During that time we've seen a decline in academics and a rise in discipline issues. 57% of the 2024 Wake budget went to education and over \$644.2 million of that was for public schools. It is time to call for accountability from the School Board, rather than writing them a blank check. I will fight to tie specific public school spending to accountability mechanisms in the Wake Co. budget. Wake County Schools need to prioritize academics, discipline, and teacher retention. I will work to end the county providing funds for DEI initiatives and liberal policies that have lowered Wake County Public School's once high national ranking. ## Chief Judge Donna Stroud, NC Court of Appeals

Judge Stroud currently serves as Chief Judge on the North Carolina Court of Appeals. She was born and raised in Kinston, NC, and attended Campbell University School of Law, graduating first in her class in 1988. Prior to becoming a judge, Chief Judge Stroud was in private practice from 1988 to 2004. She represented individuals, businesses, and municipalities in a wide

variety of cases and tried cases in many counties across the state. In 2004, she was elected as a District Court Judge in Wake County where she served until her election to the Court of Appeals in 2006. Chief Judge Stroud has been an adjunct professor at Campbell Law School since 2008. In 2014, Chief Judge Stroud graduated from Duke University's School of Law LL.M. program in Judicial Studies.

She and her husband J. Wilson Stroud have been married since 1986 and have two adult sons, Aaron and Isaac.

Since her first election in 2006, Chief Judge Stroud has faithfully served nearly two full judicial terms as one of its fifteen judges, with the start of 2022 marking her 15th year of service on the court and her first year as Chief Judge.

She believes that it is her job to enforce the law as it is written, uphold the Constitutions of the United States and North Carolina, and ensure our state courts enforce laws as they are written and every person in every case is treated fairly.

During over 15 years of service on the NC Court of Appeals, Chief Judge Donna Stroud has published over 1,000 judicial opinions. Throughout her career, this body of work has demonstrated her pro-people, pro-law and order, and pro-constitution convictions.
